Moreover we believe that the issue in question is dealing with consumers' rights: the right of the consumer, to the fact, is a political right.

Next to this we are convinced that the political right is linked to knowledge and good information is needed to make use of ones rights.

And we are back on the sociological side of the matter.

In a few days, precisely the 10th will be the European Consumer Day and referring to the "European Charter of Patients' Rights" on which ACN worked hardly since 2002, at the chapter 2-Right of access and chapter 3-Right to information we will have the series of rules that justify the motto "Patients' rights have no borders".

By the fact the YL of the Istituto Luigi Sturzo, as its founder, strongly believe in the necessity of a more and more United Europe under all aspects, we are convinced that any action which would protect the life quality of a citizen should be interchangeable in the different States of the Union.

Conscious that the task is probably demanding we are ready to get involved to achieve this goal.
