#### **Manuel Arellano**



Manuel Arellano has been a chronic kidney patient since he was 4 but was diagnosed twelve years later. In less than three months, he underwent haemodialysis sessions until 1993, when he received his first kidney transplant. After that came many complications, two bilateral testicular tumours, operated in 2008, a non-Hodgkin's lymphoma, operated in 2009 and treated with radio and chemotherapy. In December 2014, he received his second kidney transplant. Over the past three years, he has also developed cardiovascular issues and osteoporosis. His education goes hand in hand with the disease. He started studying law, books and reports accompanied him during dialysis sessions. Then he obtained a master's degree in business management and marketing. These studies enabled him to work as a business consultant for almost 10 years.

In 2010, a legal inability to work allowed him to collaborate with the association of renal patients in Navarra, his home town. A year later he was appointed president of the Association for Kidney Diseases of Navarra (ALCER). In 2013, the association joined COCEMFE Navarra, a Federation of Associations of People with Disabilities, of which he was appointed president six months later. The representation of this entity, which welcomes the largest number of disabilities in the area, made it possible for him to join CERMI Navarra, a Confederation of people with all types of disabilities representing all people with disabilities in Navarre, of which he has been vice-president since 2015. In 2018, he was also elected vice-president of the board of the Spanish Federation of Renal Patients (FNA ALCER). FNA ALCER is part of the Spanish Platform of Patient Organisations (POP) and at the October 2018 assembly he was proposed as vice-president. Since 2021, he has been a board member of the European Patient Forum (EPF).



#### **Brando Benifei**



Brando Benifei is an Italian MEP in his second term of office, currently Head of Delegation of the Democratic Party (S&D) in the European Parliament. He has been working on health issues since the last legislature and is currently Vice-President of the European Parliament's Heart Group. Member of the interest group on Kidney Health and Antibiotic Resistance. Since its establishment in 2015, he has also been a member of the MEPs' interest group on "Patients' Rights and Cross-Border Healthcare", of which he is Co-Chair since 2019.
