

Patient Safety and Quality of Care

Background

EU action: help Member States to coordinate their efforts to protect public health by:

- Classifying and measuring patient safety e.g.
 - ✓ Co-financing of the Health Care Quality Indicators Project led by OECD
 - ✓ Agreement with WHO on delivering EU patient safety taxonomy
- Sharing knowledge and experience e.g.
 - ✓EU patient safety and quality of care expert group
 - ✓ Co-financing of the EU network on patient safety and quality of care
- Co-financing of projects (Health Programme, Research programme) e.g.
 - ✓EMPATHiE study on "Empowering patients in the management of chronic diseases"



Patient Safety and Quality of Care

Background

- ▶2nd Commission report on the implementation of the Recommendation 2009/C 151/01.
- Council Conclusions on Patient Safety and Quality of Care of 1 December 2014
- European Union Network for Patient Safety and Quality of Care, PaSQ Joint Action
- European Parliament ENVI report on "safer healthcare in Europe: improving patient safety and fighting antimicrobial resistance", voted in ENVI Committee on 14 April 2015



Patient Safety and Quality of Care

Next steps

Develop a framework for a sustainable EU collaboration on patient safety and quality of care in order to:

- Facilitate the mutual learning and the exchange of good practices and strategies between Member States
- better coordinate patient-related policies
- Facilitate the move from policies to implementation
- incorporate grass-root knowledge for evidence-based policy making.



Directive on patients' rights in crossborder healthcare (2011/24/EU)

- Transposition check
- Low level of awareness (recent Eurobarometer study)
- Evaluative study on the Directive (expected to be published soon)
- Report on implementation of the Directive by October 2015
- Mapping study on patients' rights in EU (final report expected by October 2015)



Health Systems Performance Assessment

Background

- ➤ In 2011, the Council set up a reflection process to identify effective ways of investing in health. It concluded that Member States should use Health Systems Performance Assessment for policymaking, accountability and transparency
- ➤ In September 2014, the Council Working Party on Public Health at Senior Level adopted the Terms of Reference for an Expert Group on Health Systems

 Performance Assessment
- ➤ Mission letter from president Juncker to Commissioner Andriukaitis, asking him to develop expertise on HSPA
- The Group started its activities in November 2014; it is jointly chaired by Sweden and the European Commission.



Health Systems Performance Assessment

Background

Objectives of the expert group on HSPA

- Provide participating Member States with a forum for exchange of experience on the use of HSPA at national level
- Support national policy-makers by identifying tools and methodologies for developing HSPA
- Define criteria and procedures for selecting priority areas for HSPA at national level, as well as for selecting priority areas that could be assessed EU-wide
- Intensify EU cooperation with international organisations, in particular OECD and WHO



Health Systems Performance Assessment

Next steps

Develop a forum for the exchange of experience on health systems performance assessment among Member States

- Identify tools and methodologies to assess **Quality of Care**, by the end of 2015
- Focus on **Integrated Care** for 2016 with the aim to produce a report at the end of the year, with tools and methodologies to assess the performance of integrated care
