PREAMBLE

Active Citizenship Network policy and, consequently, this Action Plan are based on the following four pillars: rights & duty, empowerment, cross-border related issues, sustainability.

Moreover, the majority of the here proposed activities represent the follow-up of initiatives already started in the last years. All have in common the following pre-conditions:

- The promotion of alliances & multi-stakeholder partnership;
- A long-term commitment instead of just spot initiatives;
- The need to guarantee a balanced dialogue and the involvement of experts coming from different EU countries, in order to avoid limiting the interaction with the EU Institutions only to the "Brussels bubble".
- The willingness to denounce what doesn't work, but also the ability to valorise good practices. Read our policy on good practice (<u>EN</u> <u>IT</u>).

This Action Plan takes into account the following factors:

- The long-term impact of the pandemic in all dimensions (health, economic, social, etc.) in all sectors of society (from the business world to the third sector, etc.) and at all levels (local/national/European/global).
- The priorities of the European institutions: the EU's long-term budget coupled with NextGenerationEU & NRRPs, EU4HEALTH, the New Green Deal, and in general all the instruments that are helping rebuild a greener, more digital, and more resilient post-COVID-19 Europe.
- The European political agenda and the priorities of our association, also related to activities carried out at the national level (Italy).
- In particular, the ACN' activity of 2023 is thought in function to draft a pre-electoral manifesto to be presented to the next candidates for the 2024 European Parliament elections.

1 - EUROPEAN POLICY DIALOGUE

MEPs INTEREST GROUP "EUROPEAN PATIENTS' RIGHTS & CROSS-BORDER HEALTHCARE", SECOND TERM (2019-2024)

Promoted on 2015 by ACN and endorsed by 32 MEPs and almost 100 associations across Europe, the <u>Interest Group</u> has renewed its commitment to be a place of dialogue – a sort of citizens' agora about healthcare related issues - for the development of the policy making process at EU level. In line with the activities carried out during the first mandate (11 events realized), the objective is to increase during this second mandate - with a multi-stakeholder

perspective – the cooperation among EU Institutions, citizen & patient organizations, experts, private sectors. Its work is focused on the <u>priorities</u> underlined by the EU Commissioner for Health and Food Safety Stella Kyriakides, the promotion of the patients' rights & the reduction of health inequalities, as underlined by the "<u>Position Paper on prevention, innovation and a new health governance for the new EU Institutions</u>", drafted by ACN with the endorsement of 18 associations.



EUROPEAN PATIENTS' RIGHTS DAY



Launched by ACN, the <u>European Patients' Rights Day</u> (EPRD) was established on 18 April 2007 at the European Parliament to highlight a number of patients' rights, drafted in the <u>European Charter of Patients' Rights</u>, that should be recognized, respected and implemented all around Europe and, over the years, it has been included in the European political agenda and it is recognized as one of the main EU Forum where to discuss the future of

European healthcare and the crucial role of patients' rights for a better Europe. Also thanks to ACN's constituency, it is celebrated every year at local, national and European level (here are some examples of the celebrations in the recent years).

The European Patients' Rights Day has at its heart, as always, the theme of recognizing and strengthening patients' rights as set forth in the <u>European Charter of Patients' Rights</u>. In particular, the 2023 edition will focus on the patients' right to access care, with special reference to the unmet needs of patients who need access to special therapies.

For this reason, the 2023 edition of the conference will be dedicated to the topic of the Advanced Therapies Medicinal Products (ATMPs), aiming at being a collector of the best and most relevant existing experiences at the European level, bringing together leading professionals and the highest institutional authorities who are touched by the topic in their areas of responsibility and intervention.

Advanced therapies are becoming not only a hope but a reality of cure for patients suffering from

serious diseases who have not yet found a concrete therapeutic answer. From the research towards a growing number of ATMPs, to their use once approved, the unifying themes seem to be essentially the following: sustainability, innovation, access, equity.





To these, from our point of view, two additional elements should be added and considered as drivers in making decisions concerning ATMPs: respect for and reinforcement of patients' rights. To know more, click here.



HEALTH EMERGENCY PREPAREDNESS AND RESPONSE: OUR SUPPORT FOR THE NEW COMMISSION'S DEPARTMENT



Within the <u>HERA Advisory Forum</u> we were selected in the <u>HERA Civil Society Forum</u> which brings together patient associations, consumer associations and healthcare professionals. The other piece of the forum is represented by the industrial component.

The HERA Consultative Forum provides a mechanism for exchanging information on medical countermeasures preparedness and response and sharing knowledge. It ensures close cooperation between HERA and the

competent bodies of the Member States, in particular with regard to the planning and implementation of HERA's scientific, health and industrial activities.

Specifically, however, the task of the Civil Society Forum is to report the opinions of the main stakeholders of civil society, and we are committed to contribute on that issue. Read our recent article "How can we optimise emergency preparedness and response?".



2 - CITIZENS & PAGs VISION FOR A HEALTHIER EUROPEAN UNION

OUR SUPPORT FOR THE EU4HEALTH 2021-2027

From the interruption of vaccinations to the postponement of cancer screenings, the Covid-19 pandemic seriously undermined the scientific progress made in 20 years by preventive medicine. As a Member of the Health Policy Platform, the EU platform dealing with health and patient's rights led by the EU Commission's DG Health and Food Safety, our efforts are focused on building a safer healthcare by increasing the awareness of patient associations & advocacy activities. Our attention is, in fact, guided by the European Union's Programme of action in the field of health for the next years. We welcomed the Programme that aims to "increase protection against global health threats", "reduce inequalities in accessing health care" and "advocate prudent and efficient use of medicines such as antimicrobials". Our expectation is, on the one hand, to identify concrete and adequate forms of patients & citizens engagement for the development of the Programme and, on the other hand, to monitor how the resources will be used, at EU and national level, starting from the implementation of National Recovery and Resilience Plans (NRRPs) across Europe.

In addition, at the end of 2022 we were selected as a member of the EMA stakeholder database. So, for 2023, we'll be more directly involved in regulatory discussions on medicines for use in the EU.

GLOBAL HEALTH

Global health & the WHO's most urgent global health challenges; the Covid-19 outbreak & the need to guarantee more resilient healthcare systems; Civic society & PAGs participation on health issues, and the creation of a European Health Union, in line with the Manifesto launched in November 2020 by the former EU Health Commissioner Andriukaitis and the one launched in 2021 by ACN titled "Addressing non-covid patients: COVID-19 lessons learned for more resilient Health Care Systems.

10 Concrete recommendations towards a European Health Union": these topics could represent the main strategic drivers of the activities in the coming years. In coherence with this goal, we have just drafted a "Global Health Charter", starting from a civic perspective, with the intent of building a holistic and conscious reading of health and contributing to providing effective solutions to the crisis and the health needs of each individual at the global level. From 2023, our intention is to raise

3 - OUR PRIORITIES IN THE HEALTH FIELD

VACCINATION POLICIES



Our commitment, over the years, on this topic (you can read here) has been appreciated and recognized by several national and European health stakeholders. At the institutional level ACN has, in fact, been appointed:

• in the Technical Advisory Group, dealing with vaccine coverage, of the <u>European Centre for Disease Prevention and Control (ECDC)</u>. In 2022 we contributed in shaping the <u>ECDC e-learning course</u> on online vaccine misinformation.

- in the <u>Coalition for Vaccination</u> (promoted by the EU Commission) as civil society's representative engaged on the topic (obtaining to include among the participants not only the European healthcare workers and students' associations as initially planned).
- in the <u>European Joint Action on Vaccination EU-JAV</u> as a collaborating stakeholder.
- in the <u>Scientific Committee for the surveillance of covid-19</u> vaccines, led by AIFA, the Italian Medicines Agency.



Moreover, our work and appeal to the EU institutions and Czech Presidency of EU, along the 2022, contributed prioritise also the adult immunization importance in the <u>European Council Conclusions</u> on vaccination!

ACN is also member of several non-institutional working groups on vaccination, such us:

- <u>Adult Immunization Board</u> (promoted by the Department of Health Sciences, University of Florence and the Centre for the Evaluation of Vaccination, Vaccine and Infectious Disease Institute, University of Antwerp).
- <u>Steering Group on Influenza Vaccination</u> (promoted by Vaccine Europe).
- Advisory Committee for the <u>IFA</u> Adult Vaccination Education Program.
- <u>DRIVE</u> (Development of Robust and Innovative Vaccines Effectiveness), as patient collaborator representative.
- <u>VAC4EU</u> (Vaccine monitoring Collaboration for Europe).

In the coming years, our commitment will continue empowering the informal network of civic and patient associations, advocacy groups, think tanks, etc. to improve the collaboration and dialogue with all the health-related relevant stakeholders.

We will work engaging citizens' and patients' associations across Europe to better know and implement vaccination policies, encouraging the exchange of information and the collection of data, ensuring greater coordination in joint advocacy activities at the European level, with the final goal of improving vaccination uptake.

In the last years in particular our work focused on activating stakeholders to engage with EU institutions and inform EU policy, to support the need for strengthening the life-course approach to vaccination in Europe and spreading the value of routine immunization and its gains.



For 2023 in particular, our commitment on vaccination will be linked especially to adult vaccinations, non-communicable diseases, antimicrobial resistance, vaccine-preventable respiratory diseases (VPRDs), through the following initiatives:



- Training sessions on increasing awareness and identifying advocacy activities to better ensure sustainable access to vaccines. Because each one of us, when well-informed, represents a good antidote to the spreading of fake news.
- Targeted communication campaign co-created with the direct involvement of associations and experts.
- European institutional events, in the second half of the year to look at 2024 EU elections.

More in general we will continue to work in the following directions:

- contribute starting from citizens' and healthcare stakeholders' perspectives to understanding
 the impact of the COVID-19 pandemic (and related new vaccines) on national immunization
 plans and to support at the same time, the uptake of the routine immunization schedules.
- increase health literacy on vaccination and life-course immunization: work to build a proper vaccine culture, particularly to overcome the idea that vaccination is only needed at early ages, and to shift to a life-course vaccination approach.
- promote the institutional dialogue between citizens' associations and EU institutions.

PATIENT SAFETY, HEALTHCARE ASSOCIATED INFECTIONS (HAIS), ANTIMICROBIAL RESISTANCE (AMR)



As you can read, Cittadinanzattiva-Active Citizenship Network has worked continuously to advocate for safer healthcare both at the national and at the European level, starting from some of the rights listed in the European Charter of Patients' Rights. In the fight against antimicrobial resistance, in 2019 ACN has been recognized as official collaborating stakeholder of the European Joint Action on Antimicrobial Resistance and Healthcare-Associated Infections (EU-JAMRAI) and has been

invited to join the jury of the EU-JAMRAI's <u>contest</u> "Be a change maker: craft your own symbol, wear it with pride and raise awareness about antibiotic resistance".

As a follow up of the 14th edition of the European Patients' Rights Day, titled "ONE health approach, MULTIPLE answers: Citizens' engagement & stakeholders' actions to tackle antimicrobial resistance and sustain EU progress", our commitment to fight the AMR paradoxes in the age of COVID-19 have been focused on the following activities:





- to support multi-stakeholder coalition and the existing AMR Patients' alliances (like the ones promoted by <u>IAPO</u> and <u>EPHA</u>) with the aim of enlarging its constituency and to move, towards a citizen AMR alliance, in line with the One Health Approach. At the end of 2022 we have officially join the <u>AMR Patient</u> <u>Group</u> led by HFE.
- to promote and support training seminars on the theme of the Antimicrobial Resistance open to the leaders of civic and patient associations coming from EU Member States and beyond. Here some examples, in 2022 and 2023 (in Italy and abroad).
- to develop targeted communication strategies to increase AMR risk perception.
- to monitor the implementation of AMR national plan across Europe with the direct involvement of PAGs & citizen organizations.
- t promote tailored actions to raise awareness on the issue of AMR also for all citizens as consumers: What is behind the "antibiotic-free supply chain" message?

Our commitment to implement patients' rights in cross-border healthcare (CBHC) started many years ago, supporting the drafting first, and then the implementation, of the Directive 2011/24/EU. The MEPs Interest Group "European Patients' Rights & Cross Border Healthcare" and the widespread Communication Campaign "Patients' rights have no borders" are some relevant examples.

In line with the <u>EU4Health Programme</u>, our proposal is aimed:

Our intense efforts in 2022 to increase access to advanced therapies for all European patients resulted in the following activities: a European webinar for leaders of EU civic and patients' advocacy carried out in May 2022 with almost 100 participants; a "Call to action" signed by 43 patient associations; an institutional dialogue event at the European Parliament on 24 October 2022 followed by more than 100

people.

For 2023-

we will focus again on advanced therapies in order to ensure a high focus on the topic in the next legislative term and, at the same time, to provide the leaders of civic associations and patient advocacy groups the opportunity to participate in an EU debate about this important issue.

NON-COMMUNICABLE DISEASES, CHRONIC CONDITIONS, CAREGIVER



Oncological and chronic patients have been left almost alone for a while and, at the end of the emergency situation due to the Covid-19 pandemic, we will count not only the dead for Covid-19, but also the number of people who died because they didn't have a chance to receive adequate treatments.

For instance, in Italy, according to the Italian Society of Cardiology, the fear of infection has tripled the mortality rate due to heart attacks. A situation confirmed also at the global level by the European

Society of Cardiology, that in early June of 2020 denounced that the number of heart attack patients seeking urgent hospital care has dropped by more than 50% during the Covid-19 pandemic. Also for this reason, Cittadinanzattiva-Active Citizenship Network, as done for the past 15 years, will continue to increase its contribution for NCDs & chronic patients, not COVID-19 patients.



In particular, our intention is to continue to cooperate for the prevention of cardiovascular diseases, raising consciousness and access to treatment, aiming at reducing their burden across Europe, as you can read on our website (EN - IT). In particular for the next years, ACN will be engaged to:

• support the "This is living" communication campaign, which is focused on the protection and empowerment of patients suffering from a chronic condition at the global level.



- promote a special focus on diabetes, in order to make enforceable the rights written in the "Manifesto of the rights and duties of diabetic", based on the EU Charter of Patients' Rights;
- in coherence with our <u>cooperation</u> for the "<u>Charter on Urban Obesity</u>", will be committed on the obesity field, also thanks our partner European Association for the Study of Obesity (EASO);
- We'll contributed to increase the attention and the commitment of the European institutions
 on the issue on pain: also thanks our efforts, chronic pain is mentioned in the 2017 <u>Conclusions</u>
 of the Council of the European Union; the European Union has recently allocated more funds
 for research dedicated to the topic; DG-Santè has opened its <u>EU Health Policy Platform</u> to a
 group of experts on the subject; the European Parliament hosts an Interest Group and initiatives
 on the subject; etc. <u>Here</u> you can find our long-term commitment on the topic.
- From 2023 Active Citizenship Network will be also involved in new challenges advocation for people with ostomy in Europe.

HEALTH LITERACY & OUR COMMITMENT TO FIGHT PANDEMIC



Evidence collected during the COVID-19 crisis shows that the pandemic has had a significant impact on health services, clinicians, and patients. For instance, oncological and chronic patients struggled to access vital care, especially during the first wave of the pandemic.

Exactly three years after the widespread lockdowns, the situation has thankfully changed for the better. However, despite the enormous progress, we are not free from COVID-19. It is therefore important, as we return to some semblance of normality, that messaging about the virus is clear. The COVID-19 pandemic has posed significant challenges to patient communities, and Active Citizenship Network, in continuity with its commitment to fighting COVID-19, is committed to helping find solutions to these challenges. In particular, continuing to bring attention to the issue and ensure COVID patients do not continue to experience the neglect and abandonment that non-COVID patients experienced during the pandemic, Active Citizenship Network has decided – through two different EU projects – to invest along 2023 in health literacy to better help mitigate the effects of COVID. Fostering opportunities for discussion allows leaders of civic organisations and Patient Advocacy Groups (PAGs) to better share their needs, concerns, and best practices in the prevention, management, treatment, and follow-up of COVID-19. This will enable us to improve the current situation of care for patients with this disease. Health literacy thus becomes a very powerful tool for individual and public health assurance that allows us to understand that health is a public good to be preserved through individual preventive actions that become even more effective the more we follow them.

The COVID-19 pandemic has taught us how much damage an uninformed citizen and patient - who perpetrates unhealthy health-related behaviour - can cause and how much, on the other hand, an informed and educated citizen and patient can make a difference not only to his or her health but to public health in general. As declared by experts, the COVID-19 infodemic (an excessive amount of information about a problem that is typically unreliable, spreads rapidly, and makes a solution more difficult to achieve) showed that low health literacy of a population is a globally underestimated public health problem. For example, in Europe, nearly half of the adults reported having problems with health literacy and lacked relevant skills to take care of their health and the health of others. Two new projects "Improving health literacy for better public and patient



involvement in mitigating COVID-19 pandemic using interactive and intuitive educational tools" & "Protecting the value of access to care during - and after - the COVID-19 pandemic across Europe: focus on antivirals" — tailored to representatives of Patients Advocacy Groups (PAGs) & civic associations coming from the EU - will allow to provide a common set of updated information, to share information, to identify lessons learned but also to get feedback from PAGs. DOCTOR-PATIENT RELATIONSHIP: NEW MODEL, SAME THERAPEUTIC ADHERENCE'S VALUE



The problematic management of the Covid-19 pandemic has made the limits of the current care paradigm, which is too focused on a specialist and/or hospital perspective, even more evident, so that the management of the territory is emerging strongly as the key turning point for healthcare in terms of prevention and care for the whole population, whether affected by chronic

conditions or pandemics. The classic management

model based mainly on a face-to-face doctor-patient relationship, will have to give way to an important development of remote patient management. In order to guarantee high level of therapeutic adherence we need to support the relationship of trust while developing the diagnostic activity and remote management in the doctor-patient relationship. In light of the effects of the pandemic and the responses put in place, we'd like to promote the following initiatives:

- To update and expand the ACN's European communication campaign titled "From Therapeutic <u>Adherence to Therapeutic Alliance</u>" realized in 2018 with the direct involvement of 11 national advocacy groups & patients associations leaders, as well as two umbrella organizations.
- To carry out a tailored initiative in several EU Countries: for instance, a "Civic Consultation on the National Plan on chronicity", where groups of experts will analyse links and barriers between chronic conditions and therapeutic adherence. The goal is to compare the situation
- between countries and find together proposals and gather impressions, suggestions and advices on that aspect.
- To share recent achievements and collect good practices at EU and national level regarding therapeutic adherence in different therapeutic areas.
- To contribute to enrich the <u>EU Best Practice Portal</u> with the initiatives that we have gathered so far and to include "therapeutic adherence" as a key word of the Portal led by EU Commission to

enable people to easily find initiatives connected to this topic.

To promote a Manifesto for the rights of patients living with multimorbidity and to define and suggest concrete actions for its implementation: patients with multimorbidity have complex health needs but, due to the current traditional disease-oriented approach, they frequently experience fragmented care, which increases the risk of



negative outcomes. And this is not acceptable anymore.



In this context, between the second half of 2021 and 2022 ACN carried out the European project "Therapeutic adherence during the COVID-19 pandemic across Europe: impact, experiences and perspectives from PAGs & relevant stakeholders" (Edition 2021 - Edition 2022) which led to a European survey, realised with the direct involvement of 38 PAGs across Europe, and the publication of the article: Encouraging Across Europe the Civic & Patient Advocacy Groups' Engagement in The

To continue its commitment to the topic, in 2023 ACN intends to realise a European webinar, addressed to leaders of patient associations, experts and representatives of professional groups and academia, institutions and industry representatives, to present the results of the research carried out

during the project and promote an EU policy dialogue on therapeutic adherence, with the aim to better contribute – starting from citizens' and patients' perspective - on understanding the impact of the COVID-19 pandemic on the therapeutic plans for chronic patients, with the ultimate goal of enhancing the actions and reactions implemented by PAGs and relevant stakeholders in front of the community of experts and institutions.

EUROPEAN HEALTH DATA SPACE & CLINICAL TRIALS DATA

Cittadinanzattiva-Active Citizenship Network is one of the partners of the European project FACILITATE (FrAmework for Clinical trial participants' daTA reutilization for a fully Transparent and Ethical Ecosystem) officially started on January 1, 2022. FACILITATE aims at developing an ethical, legal, and regulatory framework that allows the return of clinical trial data to study participants (patients) and other health professionals involved in their care and wants to





create a process that allows the data collected to be reused also in future research. The project thus wants to allow not only the portability of patient data, but also change the role of patients in the strategy and design of clinical trials (with many new rights and responsibilities). It is a project funded




under the Innovative Medicines Initiative, a public-private partnership that funds research and medical innovation with the European Horizon 2020 program and the European Federation of Pharmaceutical Industries (EFPIA). Cittadinanzattiva in particular is responsible for the interaction and involvement of stakeholders (patients and their associations, healthcare professionals, pharmaceutical companies, national European institutions, civic advocacy communities, ethics committees, regulatory authorities, and principal investigators): our task is to involve them and help in the development, evaluation, and adoption of the project results. <u>consumers' protection"</u> has been officially launched on February 2021 and it is in line with European Commission's initiatives as the "<u>New Consumer Agenda</u>" and the annual "Consumer Day", organized on December 1st, 2020 by DG for Justice and Consumers, titled: "<u>Consumer policy in the service of the Sustainable Development Goals and the 2030 Agenda</u>".

The aim is to highlight the connection between the European dimension and the protection of the EU citizens as users and consumers, to support a EU policy dialogue on topics such as circular economy, energy transition, climate change, economic/social/environmental sustainability. As board member of the "European Consumer Union" and consumer association appointed to represent the Italian consumer organization to the EU Commission (2016-2019), the initiative is coherent with our commitment on circular economy, responsible consumption, fight against waste, water, environment, air pollution & health, our support and active participation in the World Environment Day, The European Week for Waste Reduction (EWWR), the European Sustainable Energy Week (EUSEW), the Citizens' Energy Forum and our role as associated partners of the European Mobility Week since many years.






ACTION FOR HEALTH AND EQUITY ADDRESSING MEDICAL DESERTS

2021/2023 | AHEAD - Action for Health and Equity:

The Project AHEAD addresses the challenge of medical deserts and medical desertification in Europe in an effort to help reduce health inequalities. The main objective is to provide knowledge and tools to a group of relevant policymakers in selected Member States and other eligible countries to define design and implement evidence-based reforms in the healthworkforce field that specifically aim

to counteract medical deserts and/or prevent medical deserts. Cittadinanzattiva-ACN is the leader of WP6, which is about the Policy Dialogue at the national and EU level to

ensure a joint reflection on practical, feasible, and

acceptable policy measures to prevent and counteract

medical deserts among national and European key stakeholders and relevant decision-makers. Read more.

The project NUDGE aims to implement behavioural interventions for long-lasting energy efficiency behaviour changes, paving the way to the generalised use of such interventions as a worthy addition to policy making. 


For 2023-2024, Active Citizenship Network aims at strengthening even more its already consolidated media activity through:

The main objectives of ACN are the promotion of civic activism and participation in the political arena, and the protection of citizens' rights, which are both the strength and the uniqueness of ACN.

ACN is deeply involved and active in the
