Orazio Schillaci, Minister of Health, Italy



Prof. Orazio Schillaci is the Minister of Health of the Italian Government chaired by Giorgia Meloni. A medical doctor by training, he is Full Professor of Nuclear Medicine at the University of Rome "Tor Vergata", where is also former Rector and former Dean of the Faculty of Medicine and Surgery. In 2020, he was appointed as member of the Scientific Committee of the Italian National Institute of Health (Istituto Superiore di Sanità). He has held roles in numerous scientific bodies. He is the author of over 350 scientific publications in peer reviewed journals, and is member of the editorial

committees of numerous international scientific journals. He was sworn in by the President of the Republic on 22 October 2022.

Guido Rasi, Full Professor of Microbiology, University of Rome "Tor Vergata"



Guido Rasi is Full Professor of Microbiology at the University of Rome "Tor Vergata" and Advisor to the Minister of Health, Orazio Schillaci, as expert in field of pharmaceuticals. He is former Executive Director of European Medicines Agency (EMA) (2011-2020), former Chair of the International Coalition of Medicines Regulatory Authorities (ICMRA) (2019-2021), former Director-General of the Italian Medicines Agency (AIFA) (2008-2011) and former Director of Research at the Institute of Neurobiology and

Molecular Medicine of the National Research Council (CNR) in Rome (2005-2008). He is author of more than a hundred publications.

Gabriele Altana, Diplomatic Advisor to the Minister of Health, Italy



An Italian diplomat since 1991, over the past few years Gabriele has been Consul General in Zürich, Ambassador in Helsinki and Chief Organizer of the 2014 Italian EU Presidency. He is now assuming new responsibilities as Diplomatic Advisor to the Minister of Health.

Roberto Frangione, Diplomatic Advisor to the Minister of Health, Italy



Roberto has been Diplomatic Advisor to the Minister of Health since December 2022. Graduated in political economy from Bocconi University in Milan in 1995, he has been a career diplomat since 1997. Former Consul General at the Consulate General in New York (2013-2017) and First Counselor in Madrid (2017-2021), he served in Bucharest (2002-2005) and Oslo (2005-2007). At the Ministry of Foreign Affairs Headquarters in Rome, he directed Office IX of the Directorate-General for the Promotion of the Country System of the MAECI (2022) and previously worked at the Directorate-General for Resources and Innovation (2010-2013), the

Directorate-General for Human Resources and Organization (2008-2010) and the Directorate-General for Development Cooperation (1998-2002).

Massimo Andreoni, Full Professor of Infectious Diseases, University of Rome "Tor Vergata"



Massimo Andreoni is Full Professor of Infectious Diseases at the University of Rome "Tor Vergata", as well as specialist in Internal Medicine and Infectious and Tropical Diseases. He was President of the Italian Society of Infectious and Tropical Diseases (SIMIT) between 2013 and 2016. Since 2017, he has held the role of SIMIT Scientific Director. He is member of various commissions at the Ministry of Health. Prof. Andreoni has been coordinator of numerous national and international research projects and is the author of approximately 300 publications in peer-reviewed

international journals and book chapters. His research focused on serious infections from bacteria, viruses and parasites in immunosuppressed patients. Part of this research activity was carried out in the United States at the Children' Hospital in Birmingham, Alabama.

Shyam Bishen, Head of the Centre for Health & Healthcare and Member of the Executive Committee, World Economic Forum



Dr. Shyam Bishen is a senior healthcare executive and board member with over 25 years of global experience in healthcare arena. He joined the World Economic Forum as the Head of Centre for Health and Healthcare and Executive Committee Member in early 2022 from Bill and Melinda Gates Foundation in Seattle where he was a regional director for seven years and was responsible for partnering to harness advances in healthcare to save lives. Before moving to Gates Foundation, he headed up emerging markets strategy, innovation, and biosimilars business at Merck (MSD) in the US as

vice president and general manager. At WEF, Dr. Bishen is engaging with the foremost political, business, cultural and other leaders of society to shape global health and healthcare agenda. Dr. Bishen is qualified with a Doctorate from the University of Newcastle. He also holds a master's in business administration from Washington University in St. Louis. Major activities of the OECD Health Division cover the response to the COVID-19 crisis and

solutions to make health systems more resilient; trends in health spending; measuring of health care outcomes, activities and inputs; health care quality policies; assessing health system efficiency and value for money; health workforce; long-term care systems and ageing; the economics of public health; pharmaceutical policies, new technologies, big data and Artificial Intelligence in health (http://www.oecd.org/health). Ms Colombo is a member of the Lancet Commission on COVID-19, the Advisory Committee of the European Health Forum Gastein, the French government's Commission des comptes de la santé, and served as co-chair of the WEF Global Future Council on Health and Health Care, and other international advisory panels. Over her career, she travelled extensively in Europe, South America and Asia, advising governments on health system policies and reforms.

Kevin Outterson, J.D., LL.M., is Austin B. Fletcher Professor of Law at Boston University, where he co-directs the Health Law Program (ranked #1 in the country by U.S. News & World Report). He is also the founding Executive Director and Principal Investigator of Combating Antibiotic-Resistant Bacteria Biopharmaceutical Accelerator (CARB-X). Professor Outterson's primary areas of expertise are the law and economics of antimicrobial resistance, particularly push and pull incentives for antimicrobials. Professor Outterson has participated in many major reports and initiatives

on antibacterial research and development. He served on the Advisory Panel for the Longitude Prize that offers an award for inventors creating affordable and rapid diagnostics to help clinicians identify effective antibiotics to treat drug-resistant bacteria. Professor Outterson received the 2015 Leadership Award by the Alliance for the Prudent Use of Antibiotics for his research and advocacy work.

Diana Peters, Head of European Government Relations and Head of Office, Germany



Diana leads Wellcome's European Government Relations and is Head of the Germany Office. She is a global health specialist with more than 18 years of international work experience. He is elected member of US National Academy of Sciences (NAS), the American Institute for Medical and Biological Engineering (AIMBE)the European Molecular Biology Organization, the Royal Society of London, and President, International Union of Microbiological Societies. He has published 797 works in peer-reviewed journals. He introduced novel scientific concepts like genetic detoxification, cellular microbiology, reverse vaccinology, and pangenome. He has developed licensed vaccines among which for acellular pertussis,

meningococcus C, and meningococcus B. Dr. Rappuoli is among the world scientific leaders dedicated to the sustainability of global health.
